TERMS AND CONDITIONS

I/We hereby apply for a new water connection and agree as follows:

- i. That the connection shall be made only after approval and upon full payment of all applicable fees, deposits, and charges as prescribed by the Water Service Provider (WSP).
- ii. That all pipes, fittings, and accessories installed from the main supply up to and including the meter shall remain the property of the WSP, and I/We shall maintain plumbing beyond the meter, including the security of the meter.
- iii. That the water supplied shall be used solely for the purpose stated in this application and shall not be extended, sold, or shared without prior written consent from the WSP.
- iv. That I/We shall pay all water bills promptly as per the approved WASREB tariffs and understand that non-payment may result in disconnection without further notice.
- v. That authorized WSP staff shall have access to the premises for meter reading, inspection, maintenance, or disconnection whenever necessary.
- vi. That the WSP shall not be held liable for any loss, damage, or inconvenience arising from interruptions, low pressure, or causes beyond its control.
- vii. That I/We shall not tamper with or allow any illegal connection to the water supply system and understand that such actions are offences under the Water Act, 2016.
- viii. That I/We agree to comply with all applicable laws, by-laws, and regulations governing water supply services as may be amended from time to time.
- ix. That the information provided in this application is true and complete, and I/We have read, understood, and accepted these Terms and Conditions.
